DECREE that modifies the Tariff of the Law of General Import and Export Taxes.

ANDRÉS MANUEL LÓPEZ OBRADOR, President of the United Mexican States, in exercise of the power conferred on me by article 89, section I of the Political Constitution of the United Mexican States, based on articles 131 of the Constitution itself; 31 and 34 of the Organic Law of the Federal Public Administration and 2nd, 4th, section I and 12 of the Foreign Trade Law, and

CONSIDERING

That on June 18, 2007, the Law on General Import and Export Taxes was published in the Official Gazette of the Federation, which establishes the Tariff Rate applicable to the import and export of merchandise in national territory;

On the other hand, on December 24, 2008, the Decree by which the Tariff of the Law of General Import and Export Taxes (Tariff) was modified was modified in the Official Gazette of the Federation. By means of several published in the same official dissemination body on December 31, 2012, December 26, 2013, August 29 and December 26, both of 2014, and May 10, 2016, by means of which a scheme of gradual tariff reduction applicable to the footwear, textile and clothing sectors, whose last stage began on January 31, 2019, with respect to the tariff fractions established in Article 7 BIS of said Decree;

That on August 29, 2014, the decree establishing measures for productivity, competitiveness and combat of undervaluation practices of the footwear sector was established in the said official dissemination body, which establishes that the Secretariats of Finance and Public Credit and of Economy, within the scope of their respective attributions they will have to implement actions to prevent and combat the practice of undervaluation of imported merchandise;

That on December 26, 2014, the Decree establishing measures for productivity, competitiveness and combating undervaluation practices of the textile and clothing sectors was published in the Federal Official Gazette, which establishes that the Treasury secretariats and Public and Economic Credit, within the scope of their respective attributions, they must implement actions to prevent and combat the practice of undervaluation of imported goods;

That on April 10, 2019, the "Decree by which the Tariff of the Law of General Import and Export Taxes and the Decree by which the general tax is established is published in the Official Gazette of the Federation of importation for the border region and the northern border strip, "by means of which it was determined to modify the tariffs of various tariff sections of the footwear sector so that they were valid for 180 calendar days or so that in that period others began their validity;

That on the date mentioned in the previous recital, the "Decree by which the Tariff of the Law of General Import and Export Taxes is modified, the Decree by which various Sector Promotion Programs are established, the Decree was published establishing the general import tax for the border region and the northern border strip and the Decree for the Promotion of the Manufacturing, Maquiladora and Export Services Industry", in which it was also determined to modify the tariffs of various fractions tariffs of the

textile and clothing sectors so that they had a validity of 180 calendar days or that during that period others began their validity;

That these measures were adopted in order to generate the space necessary for the national industry to have the capacity to face the challenges arising from the tariff reduction;

That, in accordance with the provisions of the previous recitals, the period of 180 calendar days to which they refer, is about to be fulfilled, so it is necessary and urgent to establish and extend during this Administration the increase of the tariff for 43 tariff sections of the sector footwear and 274 tariff sections of the textile and clothing sectors, in order to continue giving certainty to the footwear, textile and clothing sectors and, thus, support the domestic market, and

That in accordance with the provisions of the Foreign Trade Law, this Decree has the opinion of the Foreign Trade Commission, I have had the right to issue the following

DECREE

Article One.- The tariffs of the tariff fractions of the Tariff of the Law of the General Import and Export Taxes, published in the Official Gazette of the Federation on June 18, 2007 and its subsequent modifications, are modified below.
