Meksika Ticaret Müşavirliğimiz tarafından iletilen yazıda, Meksika Genel İthalat ve İhracat Vergileri Kanunu kapsamında 19.12.2024 tarihli Meksika Federal Resmi Gazetesi'nde yayımlanarak yürürlüğe giren Kararname ile adil piyasa koşullarının sağlanması ve yerli sanayinin desteklenmesi amacıyla, 19.12.2024-23.04.2026 arasında geçerli olmak üzere 52, 55, 58, 60, 61, 62, 63 üncü fasıl ile 9404.40.01 dahil 155 gümrük tarife kodunda gümrük vergilerinin %15 ila %35 arasında değişen oranlarda yeniden tesis edilmesine yönelik bir düzenleme yapıldığı bildirilmektedir.

DECREE amending the tariff of the General Import and Export Tax Law and the Decree for the Promotion of the Manufacturing, Maquiladora and Export Services Industry.

On the margin a seal with the National Coat of Arms, which says: United Mexican States.-Presidency of the Republic.

CLAUDIA SHEINBAUM PARDO, President of the United Mexican States, in exercise of the powers conferred upon me by articles 89, section I, and 131, second paragraph of the Political Constitution of the United Mexican States; based on articles 31 and 34 of the Organic Law of the Federal Public Administration, and 4th, section I, and 12 of the Foreign Trade Law, and

CONSIDERING

That Article 25, first paragraph, of the Political Constitution of the United Mexican States (CPEUM) establishes that " it is the State's responsibility to lead national development to ensure that it is comprehensive and sustainable, that it strengthens the sovereignty of the Nation and its democratic regime and that, through competitiveness, the promotion of economic growth and employment and a fairer distribution of income and wealth, it allows the full exercise of freedom and dignity of individuals, groups and social classes " ;

That article 131, second paragraph, of the CPEUM confers on the Federal Executive the extraordinary power to increase, decrease or suppress the export and import tariff quotas issued by the Congress of the Union, and to create others, as well as to restrict and prohibit imports, exports and the transit of products, articles and effects, when it deems it urgent, in order to regulate foreign trade, the country's economy, the stability of national production or to carry out any other purpose, for the benefit of the country;

That the General Agreement on Tariffs and Trade, which is part of the Marrakesh Agreement establishing the World Trade Organization, whose promulgating decree was published in the Official Journal of the Federation (DOF) on December 30, 1994, allows the States Parties to make adjustments to their tariffs applied to imports, as long as these do not exceed those bound in the list of concessions agreed upon within the framework of said organization;

That on November 1, 2006, the "Decree modifying the various for the promotion and operation of the export maquiladora industry" was published in the DOF, to become the "Decree for the Promotion of the Manufacturing, Maquiladora and Export Services Industry" (IMMEX Decree), which has been modified by various publications in the same official dissemination body on May 16, 2008; December 24, 2010; January 6 and July 28, 2016; October 5, 2017; April 10, September 20 and December 20, 2019; December 24, 2020; May 17, 2021, and November 18, 2022, with which the Programs for the Promotion and Operation of the Export and Temporary Import Maquiladora Industry were integrated to carry out industrial or service processes for export goods and for the provision of export services;

That the "Decree by which the Law on General Import and Export Taxes is issued", published in the DOF on June 7, 2022 and modified by various publications in the DOF on November 18, 2022; January 6 and 16; May 18, June 23, August 15 and December 27, 2023, and April 22 and May 8, 2024, establishes the tariff rates of said law that attend to the classification of the merchandise, and serve to determine the general import and export taxes;

That the textile and clothing industries are among the most representative in our country, whose goods are for intermediate and final consumption for various industries, such as the automotive, furniture, paper and toy industries, just to mention a few;

That, according to data from the National Institute of Statistics and Geography, from 1995 to 2000, the average annual growth rate of the Gross Domestic Product (GDP) of the textile and clothing industries grew by 6.5%, due to the positive impact of the North American Free Trade Agreement; since

2001, the GDP of these industries has not had the same activity. From 2019 to 2023, the GDP had an average annual decreasing rate of 4.8%; the textile industry had an average annual decline of 4.0%; while the clothing industry fell by 5.1%;

On the other hand, in the period from 2019 to 2023, imports of textile industry goods grew at an annual rate of 0.8%, while those of the clothing industry increased at an annual rate of 12.5%. This situation becomes particularly delicate for these industries. Firstly, because they are inputs, semi-finished and finished products, which translate into a displacement of the national industry and; secondly, because it is observed that the conditions presented by the imported products show a difference in the level of implicit prices, where goods from countries with which Mexico has not signed a Free Trade Agreement are lower than the prices of goods from countries that do have one;

That during the period from 2021 to 2023, the implicit price for blankets, curtains, bedspreads and upholstery items in countries without a trade agreement was lower by 18.48 United States dollars (dollars); for training or sportswear, it was lower by 13.14 dollars; for coats, suits, jackets, pants and dresses, it was lower by 9.81 dollars; for accessories (gloves, girdles, ties, etc.) it was lower by 2.91 dollars; for knitted fabrics, lower by 3.75 dollars; for knotted mesh fabrics and ribbons, lower by 1.67 dollars and for cotton fabrics, lower by 1.48 dollars;

That, as a result of the above, it is appropriate to establish temporary tariffs of 35% on the import of goods classified in 138 tariff fractions relating to clothing and 15% on the import of goods classified in 17 tariff fractions relating to the textile industry, in order to continue with the measures necessary to provide market conditions to the sectors of the national textile and clothing industries that face disadvantageous situations in international trade and to promote the development of the national industry;

That sections I, II and III of article 4 of the IMMEX Decree establish the periods during which merchandise may remain in the national territory, temporarily imported to carry out manufacturing operation processes by companies with a Program authorized under the aforementioned Decree to carry out manufacturing operations, in any of its modalities, granted by the Ministry of Economy to a legal entity to operate under the IMMEX Decree (IMMEX Program), and that the penultimate paragraph of the aforementioned article establishes that the merchandise indicated in Annex I of the IMMEX Decree may not be imported under the Program ;

That article 24 of the IMMEX Decree establishes the obligations of those who have authorization from a Program, in particular, sections IV and V indicate, the use of the merchandise for the authorized purposes and the return of the merchandise within the corresponding time periods, respectively;

That chapters 61, 62, 63 and subheadings 9404.40 and 9404.90 of the TIGIE classify made-up goods that are considered finished garments, while subheadings 6117.90, 6217.90, 6302.91, 6302.93 and 6302.99 classify cuts of fabric for clothing;

That in 2023, 1,338 million finished pieces and 331 million pairs of finished garments were temporarily imported under the IMMEX Decree, and 1,174 million pieces and 233 million pairs of finished garments classified in the goods in chapters 61, 62, 63 and subheadings 9404.40 and 9404.90 were exported. Likewise, as of September 2024, 1,124 million pieces were imported and 821 million finished pieces were exported, and as for pairs, 222 million were imported and 133 million were exported;

It follows from the above that the return of said goods has not been complied with, causing damage to the competitiveness of the national industry, therefore, it is necessary to take actions to avoid practices that affect employment and the competitiveness of the national industry. Likewise, in order to limit the possibility of other types of practices, such as technical smuggling, it is required to establish that finished clothing goods classified in chapters 61, 62, 63 and subheadings 9404.40 and 9404.90 may not be temporarily imported under the IMMEX Decree; as well as excepting subheadings 6117.90, 6217.90, 6302.91, 6302.93 and 6302.99 that classify cuts of fabric for clothing;

That section C of Annex II of the IMMEX Decree establishes the goods that must meet specific requirements in order to be temporarily imported under said Decree, and therefore, based on the

above, it is necessary to eliminate 302 tariff fractions from said section C that correspond to chapters 61, 62, 63 of the Tariff of the General Import and Export Tax Law and in turn include them in Annex I of the IMMEX Decree, also adding to the latter a tariff fraction from chapter 63 and two tariff fractions from subheadings 9404.40 and 9404.90, and

For the reasons stated above and because the measures referred to in this instrument have the opinion of the Foreign Trade Commission, in accordance with the provisions of the Foreign Trade Law , I have seen fit to issue the following

DECREE

I. Modifications to the tariff of the General Import and Export Tax Law.

First. The tariffs of the tariff fractions of the Tariff of the General Import and Export Tax Law, published in the Official Gazette of the Federation on June 7, 2022, and its subsequent amendments, are temporarily **modified** until April 23, 2026, as indicated below :
